40 Year Limited Parts Warranty

Limited Parts Warranty – Gutterglove, Inc. (*herein referred to as GGI*) warrants to the original owner(s) that its specially designed Gutterglove Pro® Gutterguard will not be defective in manufactured parts, and agrees that it will, at its option only, either repair the broken part or replace it with a new or reconditioned equivalent. This Limited Warranty is valid for 40 years for the Gutterglove Pro Gutterguard for the parts only and does not include cost of labor for re-installation or shipping costs. In coastal areas, warranty is reduced to 10 (ten) years for parts only. "Coastal areas" is defined as anywhere within 5 (five) miles of the coast. Gutterglove Pro is subject to the following terms and conditions. No other warranty is expressed or implied in this Limited Warranty. You may also have other rights which vary from state to state.

Coverage Exclusions and Limitations – The above mentioned warranties are void if any of the following conditions occur: Improper installation; settlement of building structure; Structural shrinkage or distortion of structure (*Example: warping of roof or gutter over time etc.*); Vandalism; Hail; Fire; Tornado; Windstorm; Earthquakes; Lightning; Protective liquids or any type of roof preservation product applied to roof tops to extend the life of a roof; Maintenance Procedures are not followed properly; Tree sapping on mesh; Insect/bird droppings on mesh; Accidental damage; Acts of God; Misuse or abuse of the gutter guard; Mildew accumulation; Paint overspray; Moss or algae growth accumulation; Impact of foreign objects; Normal weathering; Caustic atmospheric conditions (*Example: Acid rain, harmful chemicals, etc.*) or any other causes beyond the control of GGI. **Note: As with all gutter guards, icicles can form in freezing weather conditions where snow is present.**

GGI's obligation under this warranty shall at no time exceed the original purchase price of this product at time of sale, but not for installation or re-installation costs. These warranties cover only Gutterglove Pro and do not cover the gutter or any part of the building structure.

GGI reserves the right to withdraw this warranty from the market at any time. Any and all warranties in effect at the time of removal will not be affected by the withdrawal, and will remain in effect until their expiration. This warranty is transferable to any new property owner.

GGI cannot and will not be liable to the original purchaser for a breach of any written or oral express warranties, such as those given to you by a GGI dealer, contractor, sub-contractor or installer of Gutterglove Pro. Gutterglove Dealers are not affiliated in any way with GGI and are their own separate entities. Any implied warranties imposed by law, such as the implied warranties of merchantability and fitness for a particular purpose are limited in time to the duration of this warranty. GGI shall not be liable for any consequential damages for breach of any express, written, oral, or implied warranty on Gutterglove Pro. Your exclusive remedy shall be repair or replacement solely at GGI's option, only on terms stated in this warranty. Some states do not allow the exclusion or limitation of incidental or consequential damages and some states do not allow limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you.

Registration of Warranty – This warranty becomes effective when the installer and the owner complete this warranty application and mail it to the GGI corporate office within 60 days after the installation is complete. Failure to do so will render this warranty null and void.

Claims Procedures – Any claim made hereunder must be presented to GGI within the warranty period within a reasonable period of time after discovering the defect. The claim should make reference to original date of installation and the purchaser's name, address, and phone number.
